Call for Nominations: BCS Community Credit Union Board of Directors

f you'd like to get involved with the credit union and represent the members; if you think you have something to offer and would like to volunteer your time; if you would like to run for a seat on the Board of Directors or Supervisory Committee, now is your opportunity to submit your name for nomination.

If you're interested in running for election please submit your Resume along with a cover letter explaining why you want to become a credit union volunteer, include your experience and expertise, and state how the credit union could benefit from your involvement.

The board of directors of a credit union is elected by the members of the credit union at the annual meeting. Directors cannot be paid for their time or services, and directors must be bondable and must pass a background check and undergo other verifications. Candidates must be at least 18 years of age and a member of the credit union in good standing prior to running for election.

Candidates for the Board of Directors should possess a dedication and commitment to the purposes of the credit union movement and to the credit union. An understanding of basic business procedures and an ability to read a balance sheet is also helpful. Certain training is also required. Attendance at most monthly Board meetings is required.

Please submit your letter and Resume to the credit union office by 5:00 p.m., Friday, May 5, 2017. The nominating committee will review all applications and notify suitable candidates and place their names on the ballot. Elections are to be held during the credit union's annual meeting on May 16.
